## ASSESSOR JEFFREY PRANG OFFERS FREE TAX FILING SEMINARS TO SMALL BUSINESSES

**LOS ANGELES, CA** – Los Angeles County Assessor Jeffrey Prang has announced free seminars for small businesses to educate business owners on the preparation and filing of Business Property Statements (Form 571-L). The seminars are intended to provide helpful information and one-on-one guidance to business owners.

Businesses are required by law to file an annual Business Property Statement if the combined cost of business personal property is \$100,000 or more. This includes, but is not limited to, machinery, computers, equipment, furniture, and supplies.

“These free seminars are informative for business owners who may require assistance with completing and the filing of Business Property Statements,” said Assessor Jeffrey Prang. “My team will provide a detailed overview and answer any questions regarding the filing process.”
