- Line 3. Report the cost of Motion Picture Production Sets in use.
- Line 4. Report the cost of new unused media.
- Line 5. Report the total cost (add lines 1-4).
- Line 6. Report the cost of Television Production Sets in the spaces provided for the appropriate level of idleness, and enter the total cost.
- Line 7. Report the cost of Motion Picture Production Sets in the spaces provided for the appropriate level of completion, and enter the total cost.
- Line 8. Report the cost of Television Production Sets Out Of Production in the spaces provided for the appropriate time frame, and enter the total cost.
- Line 9. Report the number of reels and cans on hand as of 12:01 a.m. January 1.
- Line 10. Report the number of used media (e.g., Videotapes, DVDs, CDs).
