The information shall be taken from the annual report of the State Public Utilities Commission, except that a company may file with this statement its annual report to the Commission in lieu of all data except (a) a segregation of transportation equipment between licensed and unlicensed vehicles, (b) the "preceding 4 years" income data, and (c) the three questions in the section with the heading "Property Owned by Others."
